The right of asylum (sometimes called right of political asylum, from the Ancient Greek word  $\pm i\sqrt{3}$  is an ancient juridical concept, under which a person persecuted by one's own country may be protected by another sovereign authority, such as another country or church official, who in medieval times could offer sanctuary.
