Personal services income (PSI) is income produced mainly from your skills or efforts as an individual. Income is classified as PSI when more than 50% of the amount received was for your labour, skills or expertise. Special tax rules (the PSI rules) may affect how you report that income to us, and the deductions you can claim.
